## RECENTLY COMPLETED DISPUTES MATTERS

### **Penalty for Misconduct imposed on Miss Rachael Addison arising from SHCV Measuring Day is:**

1. Payment of \$1,191.56 being Drug Testing costs for the horse "Exuberance"
2. Three months suspension of SHC Membership for Rachael Addison effective from 10<sup>th</sup> December 2013
3. Fine of \$1,000
4. Payment of Costs & Fine to be paid within three months of this date. Failure to comply will result in suspension or non-acceptance of application for membership by Rachel Addison being extended until the account is paid in full. Invoice attached.
5. The outcome of Disciplinary action applied to Rachael Addison shall be circulated to SHC Affiliates.

### **Penalty for Misconduct imposed on Mrs Jan Lyons arising from NSW HOTY is**

1. Fine - \$500
2. 12 months suspension/ban of the horse "K.G. Goodness Gracious" rendering it ineligible for SHC Competition until 10<sup>th</sup> February 2015
3. 12 months suspension/ban of Mrs Jan Lyons the Responsible Officer rendering her ineligible for SHC Competition until 10<sup>th</sup> February 2015
4. 12 months suspension of Jan Lyons Responsible Officer from Committee, Delegate and Official Judges List until 10<sup>th</sup> February 2015
5. Forfeiture of Place, Sash & Trophy Rug awarded for Champion Preliminary Pony Hack
6. Full payment of the costs associated with the drug testing (copy attached.)
7. Publication of results in relation to penalties in accordance with Competition Rules 1.6 (a) and 1.7 (b)

**Penalty for Misconduct imposed Mr James Hall** arising from his behaviour at the Special General Meeting of Leisure Coast Hack Association held on 30<sup>th</sup> August.

"Membership of Mr James Hall to be shown as terminated in SHC records and any future Application by Mr James Hall for membership of a Show Horse Council Affiliate shall be placed before the Show Horse Council for its consideration."

**RAS entry ban** imposed on Sarah Adams has been extended indefinitely at the discretion of the RAS committee. This ban will be upheld by SHC and she will be ineligible for SHC Competition until the RAS ban is lifted.

## NSH Registrar's Report

Hi all! I have now been in the Office for over a year, and I would like to thank the Committee and all of the Members for their support. It has been lovely to be able to talk to so many Members around Australia. Paperwork at the Office is pretty much up to date – so if you have sent anything to me and have yet to hear, please contact me.

Just a few things to bear in mind when getting paperwork together:

- Everything to do with the National Saddle Horse Register should be sent to me at the Richmond PO Box address – sending your paperwork to Roma, Leonie, or your Affiliate will hold up the process as it will then need to be re-directed to me;
- Memberships are handled by the Affiliate or Constituent Affiliate - they are separate financial entities;
- Verification for new registrations is no longer required;
- I can only accept new registrations, leases or requests for replacement Certificates (where the original has been lost or misplaced) by email;
- Transfers, requests for Change of Name or requests for amendments to Certificates must be sent to me by post accompanied by the original Certificate of Registration;
- When sending in a transfer – please make sure that the reverse of the Certificate has been completed by the previous owner **and** the purchaser, and that the date of purchase has been filled in;
- If you are paying by credit card, please remember to include the expiry date!
- Please attach a payment sheet to all transactions

Please be aware that from 1 July 2014 Applications for NSH Registration WILL NOT be accepted without the horse having a micro chip (regardless of whether they are branded or not).

I am here at the Office between 9.30am and 3.30pm Monday to Friday (except Public Holidays). Please do not hesitate to give me a call if you need any assistance at all. If I am not going to be in the Office for over a day, the answering machine will tell everyone when I will be back.
